## TERMS AND CONDITIONS OF CREDIT RELATIONSHIP

Applicant agrees that any extension of credit is subject to the terms and conditions set forth herein and in invoices issued to Applicant. No other terms and conditions shall become part of any sales agreement, purchase order, or other transaction, unless set forth in writing and signed by both parties. Applicant is seeking credit for commercial purposes only. If Wolfkill Feed & Fertilizer Corporation ("WOLFKILL") agrees to extend credit, all decisions regarding the granting or continuation of credit are at the sole discretion of WOLFKILL and may be terminated at any time. Applicant hereby authorizes WOLFKILL to contact credit reporting services and other third parties to determine Applicant's creditworthiness and authorizes the release of credit information from those entities to WOLFKILL. WOLFKILL assumes Applicant is solvent. Continued solvency is a precondition to any sale made by WOLFKILL. Applicant agrees to update this Application and provide financial statements upon request, and further agrees that, if there any outstanding balances currently owing, those obligations shall also be governed by this Agreement.

Applicant hereby agrees that, if credit is granted to Applicant, Applicant will pay all charges made on Applicant's account. Acceptance of goods, without notification to WOLFKILL of dispute or defect, shall be deemed an admission of liability for the amounts referenced in the invoice. Charges made during the month are billed in accordance with terms set forth on the invoice issued by WOLFKILL, and discounts are available only if the account is current. Statement balances are due and payable in full by the last day of the month in which they are mailed. If there are any parts of the bill that you believe are wrong or you need more information about a transaction you must send your inquiry in writing to WOLFKILL within 30 days after the bill was mailed to you. Any unpaid balance owed from the previous billing cycle may be subject to a Finance Charge at the rate of Eighteen percent (18%) per annum. WOLFKILL reserves the right to change these charges. All payments received or credits given may be applied first to any finance charges and the remainder to the principal balance due, at the sole discretion of WOLFKILL. Applicant agrees to be responsible for all collection costs and attorneys' fees incurred by WOLFKILL in connection with any delinquent account. The laws of the State of Washington shall be applicable to any action arising out of this Application. The parties agree that Snohomish County is the appropriate venue for such an action.

**NOTICE:** If credit is denied, you have the right to a written statement of the specific reasons for denial. To obtain the statement, please contact the Credit Division at WOLFKILL at the above address within sixty (60) days from the date you were notified of the decision to deny credit. WOLFKILL will send you a written statement of the reason(s) for denial within thirty (30) days of receiving your request.
